Jain, Managing Director of the Company, DIN: 00139764 of Arkade Developers Limited (**Company**), a company incorporated under the laws of India and having our registered office at Arkade House, Opp. Bhoomi Arkade, Near Children's Academy, A S Marg, Ashok Nagar, Kandivali (East), Mumbai - 400101, Maharashtra, India., do hereby solemnly affirm and state as follows:

The Company is proposing an initial public offering of equity shares of ₹ 10 each (**Equity Shares**) through a fresh issue of Equity Shares (**Issue**). In the financial year 2004-2005, the address of the registered office of the Company was changed from C Sagar Complex (Old Vakharia House), M. G. Road, Near Ram Mandir Temple, Vile Parle (E), Bombay-57 to 301 Pratik Avenue Nehru Road Vile Parle East Mumbai-400057.

- 3. The Company has not been able to trace the forms filed by the Company with RoC in relation to this change in the address of its registered office mentioned at paragraph 3 above.
- 4. In the financial year 1987-1988, the address of the registered office of the Company was shifted from 125, Geetanjali, Samarth Ramdas Road, J.V.P.B.S. Bombay-49 to Plot No.14, Garden View, Amritvan, Opp Dindoshi Bus Depot, Goregaon (East), Bombay-400063.
